4. First-aid Measures

5. Fire-fighting Measures

Environmental Precautions and Methods and Materials for Containment and Cleaning Up: Clean up spills in a manner that does not disperse dust into the air. Use non-sparking tools and equipment. Reduce airborne dust and prevent scattering by moistening with water. Pick up spill for recovery or disposal and place in a closed container. Do not flush to sewer!

7. Handling and Storage

Precautions for Safe Handling and Conditions for Safe Storage, Including Any Incompatibilities: Keep in a tightly closed container, stored in a cool, dry, ventilated area. Protect against physical damage. Avoid dust formation. Isolate from any source of heat or ignition. Material will accumulate static charges which may cause an electrical spark (ignition source.) Use proper grounding procedures. Do NOT pressurize, cut, heat, or weld containers. Isolate from incompatible substances. Containers of this material may be hazardous when empty since they retain product residues (dust, solids.) Observe all warnings and precautions listed for the product.
