### SECTION 4 — FIRST AID MEASURES

Restrict unprotected personnel from the area. Sweep up the spill, place in a sealed bag or container, and dispose. Ventilate area and wash spill site after material pickup is complete. See Sections 8 and 13 for further information.

Flinn Suggested Chemical Storage Pattern: Organic #2. Store with alcohols, glycols, amines, and amides.

Store in a cool, dry place. Light sensitive. Store in a Flinn Chem-Saf bag and then place in a Flinn Saf-Stor Can.

Avoid contact with eyes, skin, and clothing. Wear chemical splash goggles, chemical-resistant gloves, and a chemical-resistant apron. Use exhaust ventilation to keep airborne concentrations low.
