SECTION 2 — HAZARDS IDENTIFICATION

Hazard class: Acute toxicity, oral and inhalation (Category 3). Toxic if swallowed or inhaled (H301+H331). Do not eat, drink or smoke when using this product (P270).

Hazard class: Skin corrosion or irritation (Category 2). Causes skin irritation (H315).

SECTION 4 — FIRST AID MEASURES

Flinn Suggested Chemical Storage Pattern: Inorganic #2. Store with acetates, halides, sulfates, sulfites, thiosulfates and phosphates. Deliquescent. Store in a cool, dry place within a Flinn Chem-Saf™ bag. Keep container tightly closed (P233). Use only in a hood or in a well-ventilated area.
