SECTION 2 — HAZARDS IDENTIFICATION

Hazard class: Flammable liquids (Category 3). Flammable liquid and vapor(H226). Keep away from heat, sparks, flames, and hot surfaces. No smoking (P210).

SECTION 4 — FIRST AID MEASURES

Flinn Suggested Chemical Storage Pattern: Organic #4. Store with ethers, ketones, halogenated hydrocarbons, and ethylene oxide. Store in a cool, dry place. Keep container tightly closed (P233). Keep cool (P235). Ground or bond container and receiving equipment (P240). Use only in a hood or in a well-ventilated area (P271).
